## The Adolescent Health Equity, Prevention, and Translation (AdHEPT) ARC

## Abstract

The Adolescent Health Equity, Prevention, and Translation (AdHEPT) ARC seeks to advance cutting-edge science that addresses the most urgent health needs of adolescents and young adults (ages ~10-24). We plan to conduct and disseminate interdisciplinary research that informs practice, programs, and policies to promote health equity and improve health during a critical developmental period. Our ARC is comprised of four co-PIs/Co-Directors (**Buitron de la Vega, Nelson, Sprague Martinez, Wang**), core faculty (**Bagley, Elliott, Epstein, Gordon, Lipson**), advisory board members/consultants (Adams, Borrelli, Drainoni, Huberfeld, Kolaczyk), and eleven additional member affiliates.

Since January 2020, our ARC has had biweekly meetings to generate collaborations that integrate expertise through community-engaged, mixed methods, epidemiological, and systems science-based approaches. We propose the following aims: 1) develop a youth advisory board; 2) provide web-based workshops to the BU community in the conduct of youth-engaged health research; 3) hold monthly seminars and an annual adolescent health equity symposium; and 3) conduct two research projects focused on adolescent-specific health equity priorities that align with that of BMC/BUMC. We additionally will 4) meet monthly with ARC core and affiliate members, 5) issue RFAs for ARC members to conduct pilots, and 6) meet with successful P Center grantees. Our long-term goal is to become an independently funded interdisciplinary center.
