Required Influenza Vaccine (Flu Shot)

Starting in Fall 2020, the <u>Commonwealth of Massachusetts</u> and <u>Boston University</u> are requiring that students receive an influenza vaccine (flu shot). The vaccine requirement is an important step to reduce flu-related and other respiratory illness during the COVID-19 pandemic.

The flu shot requirement applies to*:

- All full-time undergraduate and graduate students under 30 years of age
- All full- and part-time clinical and health science students

*The flu shot requirement is for students in BU's Learn from Anywhere (LfA) Testing Categories 1, 2, and 3.

FAQs about the Flu Shot Compliance Requirement

Why are students required to get a flu shot?

<u>Per an order issued by the Commonwealth's Department of Public Health</u>, the flu shot will be required for all full-time undergraduate and graduate students under 30 years of age and all full- and part-time health science (clinical) students at post-secondary institutions.

Which students are required to get a flu shot?

Requirements apply to all full-time undergraduate and graduate students under 30 years of age and all full- and part-time clinical and health science students. These requirements are for students in BU's LfA Testing Categories 1, 2, and 3.

Students that will not be on-campus and are in BU's LfA Testing Category 4 are encouraged but <u>not</u> required to get a flu shot.

When do students need to receive a flu shot by?

The Commonwealth is requiring that students receive a flu shot no later than December 31, 2020.

At BU, students in LfA Testing Categories 1, 2, and 3 will become non-compliant if they do not receive and/or upload proof of having received the flu shot by January 1, 2021.

How do students check their flu shot compliance?

Students can view their immunization compliance on the BU StudentLink Compliance page.

To check immunization compliance, students should do the following:

- Visit the BU StudentLink
- Under the "Personal" tab, select "Compliance Status"
- Locate the Medical Immunization compliance indicator
- If there is an "N," you are non-compliant for at least one required medical immunization

- To the right of "Medical Immunization Status," select "Review and Print a copy of your immunization records" to see which immunization(s) is missing
- If there is a "Y" under "Medical Immunization Status," you are compliant for all required medical immunizations.

Are there any exemptions to receiving a flu shot?

Immunization requirement waivers can only be granted under two circumstances listed below. For no other reasons can waivers be granted.

- **Religious Waiver**: A religious waiver is provided by the student documenting their conflict with the requirement due to their religious beliefs.
- **Medical Waiver**: Physician certification that immunizations are contraindicated due to a prior adverse reaction or current medical condition.

What happens if a student does not get a flu shot?

 Getting a flu shot is part of students' University compliance and is tied to registration activity, which includes using the course planner and registering for classes. Students in LfA Testing Categories 1, 2, and 3 who do not get a flu shot by January 1, 2021 will not be able to adddrop classes or complete other registration activity.

What about students who enroll after January 2021?

- New students that meet the above indicated population criteria enrolling between January 1 and March 31 must have a documented dose of influenza vaccine for the current influenza season (along with all other required vaccinations) when they start school.
- Students that meet the above indicated population criteria enrolling after March 31 are <u>not</u> required to have a dose of influenza vaccine until they enroll in the Fall 2021 semester.

FAQs about Getting a Flu Shot

What type of flu shot do students need?

Any age-appropriate licensed influenza vaccine for the current season fulfills the requirement. This includes injectable and nasal spray vaccine types.

Where can students get a flu shot?

Students can choose to get a flu shot on- or off-campus.

On-campus:

• Student Health Services will be hosting on-campus flu clinics during the course of the Fall 2020 semester. <u>Flu clinics will be announced on the SHS calendar</u>. Flu clinics are appointment-only, and students must <u>make an appointment on Patient Connect</u>.

How much will getting a flu shot cost?

On-campus: Student Health Services will be hosting on-campus flu clinics during the course of the Fall 2020 semester. <u>Flu clinics will be announced on the SHS calendar</u>. Flu clinics are appointment-only, and students must make an appointment on Patient Connect.

- Students with the BU Aetna Student Health Insurance Plan (SHIP) can get a flu shot for free through a SHS flu clinic.
- Students that have other health insurance (private insurance) can get a flu shot from a SHS flu clinic for \$40. SHS will bill your Student Account for the cost of the flu shot. Select insurance companies might be able to reimburse students for getting the flu shot.

Off-campus: The price of getting a flu shot off-campus will depend on a student's health insurance and where they go to receive a flu shot.

How do students submit proof of a flu shot if they received it off-campus?

To upload documentation, students should follow the process listed below:

- Login to Patient Connect
- In the menu on the left, select "Forms"
- Select "Immunization Upload"
- Select "Add Immunization Record" to attach documentation
- Select "Save" at the bottom of the page

If a student is learning remotely now but may come to campus later in the academic year, do they need to get a flu shot?

The immunization requirements apply to all students who attend any classes or activities on campus, even once.

If a student is learning remotely now but may come to campus later in the academic year, we recommend receiving the flu shot and uploading immunization records into <u>Patient Connect</u> as early as possible to ensure all records are in place prior to students attending classes or activities in person.
