Greetings all GMS Master's students,

Summer 2024 registration begins on Thursday, February 15, 2024.

The <u>GMS Student Website</u> contains all the pertinent information, links, and forms to successfully complete registration process.

Students Completing Degree Requirements for August 2024 Graduation:

- Students completing their degree in one year must register for Summer 1 and Summer 2 and submit a diploma application for August 2024 graduation.
- Continuing students completing degree requirements during Summer 2024 must register for Summer 2 and submit a diploma application for August 2024 graduation.
- Diploma applications for the August 2024 graduation: MUST submit prior to April 15, 2024 deadline. Please follow the GMS Graduation Calendar for all upcoming deadlines.

Undergraduate Courses (including BT courses):

• Students may not use federal financial aid towards courses that will not count towards their degree. Graduate students may not register for PDP classes, GMS BT Courses, or undergraduate level courses. They also may not audit courses. Unapproved graduate level courses at other BU schools and colleges will not count towards degree requirements, unless previously approved by your program director and the GMS Registrar. (Only one non-GMS graduate level course may be taken with program director/chair approval)

GMS Registration information

- Students must register online via the <u>MyBU Student Portal</u> after meeting with their advisor. Not all students are required to register for the summer terms. Check with your advisor or contact the <u>GMSRegistrar@bu.edu</u> with registration questions.
- Students in the Biomedical Forensics Science will be required to obtain an Academic Advising Access Code prior to registering. Contact your advisor.
- Research credits should be in increments of two credits.

Withdrawal Deadlines:

- Absence from class or non-payment does not constitute an official withdrawal or dropped course. If your plans change and you are unable to attend a course for which you have registered, you must officially drop/withdraw from the class. Failure to do so within the add/drop deadlines for that course will result in your being held responsible for all tuition and fees associated with the course(s) in question.
- Summer 1, last day for 100% credit on tuition Thursday, May 23, 2024

- Summer 2, last day for 100% credit on tuition Friday, July 5, 2023
